

Style Guide of Title Page

■ The title page should include the items listed below and be uploaded separately to your main document

1. **Title:** concise, specific, and informative contain the major keywords.

Avoid abbreviations in the title.

2. **Authors:**

- First author, corresponding author, and co-author(s) should be distinguished from each other in order.
- Address for correspondence should include the corresponding author's name, affiliation, title, complete address including postal code, telephone, FAX number and email address.
- All authors' full names with affiliations, titles, and ORCID number should be provided. All authors are also required to submit an ORCID ID (Open Research and Contributor ID: <https://orcid.org/register>) to identify the each author.

3. **Type of article:** identify the type of your study among quantitative or qualitative research, review article, concept analysis, Q methodology, and meta-analysis.

4. **Numbers of references:** be limited to 35 for regular article, with an exception of 50 for model construction.

5. **Word count for abstract:** should not exceed 250 words.

6. **Running titles:** A short running title of less than 50 characteristics long (including spaces).

7. **Keywords:** providing up to 5 keywords

Use the Medical Subject Heading (MeSH®) thesaurus (<http://www.nlm.nih.gov/mesh/meshhome.html>).

8. **Permission :** Authors should obtain permission of instruments used in the study from original developers.

9. **Disclosure:**

1) **Dissertation:** please copy one of the following sentences applicable to your situation

- If all the tables and figures in the thesis are included in the manuscript: This article is a condensed form of the first author's master's (doctoral) thesis (dissertation) from _____ University.
- If selected tables and figures of the thesis are included in the manuscript: This article is based on a part of the first author's master's (doctoral) thesis (dissertation) from _____ University.
- This article is an extended study based on the first author's master's (doctoral) thesis (dissertation) from _____ University.
- This article is a revision of the first author's master's (doctoral) thesis (dissertation) from _____ University.

2) **Source of funding:** all the sources of institutional, private and/or corporate financial support within the manuscript should be fully acknowledged. Authors refer to the funding agency's required statements for acknowledgement.

3) **Conflict of interest:** any financial and personal relationships that could influence inappropriately you're your work must be disclosed in detail.

4) **Authorship criteria and Responsibility:** Please refer to the authorship criteria of ICMJE, 2013 (http://www.icmje.org/icmje_recommendations.pdf) and Good Publication Practice Guidelines for Medical Journals 2nd Edition (KAMJE, 2013, [http://kamje.or.kr/data/guide\(2\).pdf](http://kamje.or.kr/data/guide(2).pdf)).

Criteria for authorship include contribution to :

Study conception and/or design acquisition, analysis, or interpretation of the data; and drafting or critical revision of the manuscript for important intellectual content.
